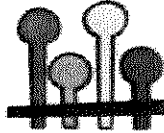

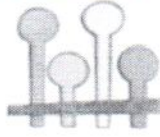

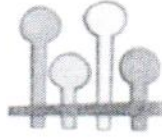

RE: RGBK acknowledgement and consent to Nabas mining application

Your letter of 19 July 2023 refers.

The RGBK took note of the following:

- That you did engage the Community Property Association (CPA) as landowner and that the CPA gave its consent for the mining application.
- That the CPA must take a decision regarding the 20% shares in Nabas Trust.
- That the RGBK must engage with the CPA regarding the Community Trustees who must serve on the Nabas Trust.
- That you did liaise with the SANParks experts. The difference of opinion is noted and we are awaiting a further discussion and opinion regarding the legality of the application.

With regards to bullet point 5 in your letter dated 19 July 2023, the RGBK need the following to be clarified:

- Is the R8/ha per month or per annum?
- That the R30 000/month paid to SANParks is in lieu for the use of the road and not for maintenance thereof.

After a thorough discussion at the RGBK meeting on the 5th September 2023, we wish to convey our consent to the mining application, provided that it adheres to all legal requirements and is in compliance with the applicable Acts.

Do proceed accordingly and please keep the RGBK updated on the progress of the application.
